

4. Principle

This product is a resin-based block to be cut or milled with a dental computer-aided design and manufacturing unit for fabricating dental restorations such as inlays or crowns.

Intended use and effect/efficacv

This product is a material to be cut or milled with a dental computer aided design and manufacturing unit for fabricating polymeric restorations for dental use.

[Instructions]

- (1) Measure an abutment tooth model using a scanning machine.
- (2) Create milling data based on measurement data, using software.
- (3) Set up this product in a milling machine and process it using milling data. After completion of processing, eliminate surplus residue. Remove sawdust and other dust from the restoration.
- (4) Correct the shape and polish in accordance with normal practice. As a final polishing, polish it with a polishing material*1 to glaze.
- (5) In cases where additional layering or characterizing after milling is needed, follow the instructions for the dental resin used for crowns and bridges*2. Surface treatment with a surface preparation agent containing silane coupling agent*3 is required before additional layering,

[N.B.: Technical Directions and Points for Attention]

- 1. When using CAM software or milling machine, follow the instruction manual provided for each device and ensure the appropriate processing conditions for this product.
- 2. Form the margin area in deep chamfer or round shoulder with over 0.8 mm thickness.
- 3. Make the thickness of pit-and-fissure more than 1.0 mm and cusp more than 1.3 mm. Round off the shape for any angle areas.

- 4. Sandblast (at about 0.2 to 0.3 MPa) the adhering surface of dental restorations using alumina powder (about 50μ m). After trial fitting, clean the adhering surface with phosphoric acid etching solution, and wash and dry to remove any inhibitor of adhesion such as protein substances containing in salvia.
- 5. For the adhering surface of the restorations, surface treatment using a surface preparation agent containing a silane coupling agent is required.
- 6. After drying, use suitable resin cement considering adhesiveness, color tone, and transparency with abutment material.
- 7. When using resin cement material, follow the instruction manual provided.
- 8. Do not use glass ionomer-based resin cement to bond this product.

- (8) Dentists should determine whether this product is suitable for use in each individual case

- (11) Remove excess cement after fixing restoration.
